Mr. Slaton accused me of violating confidentiality but refused to identify any specifics. Ms. Mathur said she was in the room when I breached confidentiality but she also failed to give even a single example. Based on this, you have agreed to agendize a motion to take disciplinary action against me.

With a "secret indictment" we are well on the path to a Soviet show trial.

It is a bedrock principal of the U.S. legal system that an accused person has the right to see the evidence against him well in advance of any proceeding in which the "evidence" will be considered. I'm entitled to know the specifics of who my accusers are and the "who, when, where and what" of the charges. As I said I cannot defend against unspecified charges.

I'm asking (demanding) that that information be provided to me at least three weeks before my "hearing." As you know I am among a very limited number of the Board of Administration members that actually reads all the agenda material. That means that the week before the Board meeting is not really available for defense preparation.

If you are unwilling to comply with this request it will further de-legitimize the whole proceeding.

I would also ask you to consider the issue of whether Mr. Slaton and/or Ms. Mathur should be allowed to vote given that they have already taken a position without even seeing the charges.
