 - d. The records that identify the real name(s) of the user(s) employing that(those) login(s)
- 3. Please provide the login of the user who was using the device assigned the internal IP address of 10.10.125.175 from 12:00 PM PDT through 5:00 PM PDT on May 3, 2017 and the records identifying the user using that login during that time period.
- 4. Please provide records that would show the physical location (to include street address or building number, and room identifier) of the devices originating the connections identified in 1. and 3. above from their points of access to the CalPERS network, whether physically or wirelessly connected.

Please provide all machine readable records in machine readable form.
