## Decree of the Government of the Russian Federation of May 11, 2022 N 851

## On measures to implement the Decree of the President of the Russian Federation of May 3, 2022 No. 252

In pursuance of Decree of the President of the Russian Federation N 252 "On the application of RESPONSIBLE special economic measures of May 3, 2022 in connection with the unfriendly actions of certain foreign states and international organizations", the Government of the Russian Federation decides:

- 1. Approve the attached list of legal entities in respect of which special economic measures are applied.
- 2. Establish a ban on the commission of actions in accordance with subparagraph "a" of paragraph 2 of the Decree of the President of the Russian Federation dated May 3, 2022 No. 232 "On the application of retaliatory special economic measures in connection with the unfriendly actions of certain foreign states and international organizations" with the persons indicated the list approved by this resolution, as well as organizations under their control (hereinafter persons under sanctions)
- 3. Determine the following additional criteria for classifying transactions as transactions, the execution of which and the fulfillment of obligations under which are prohibited in accordance with paragraphs two and three of Subparagraph "a" of paragraph 2 of the Decree of the President of the Russian Federation OT 3 Miya 2022 No. 252 "On the application of retaliatory special economic measures in connection with the unfriendly actions of some foreign states and international organizations":

transactions made in favor of persons under sanctions: transactions involving the entry into the ports of the Russian Federation of ships owned and (or) chartered by persons under sanctions, in their interest or on their behalf;

transactions involving the making of payments, transactions with securities with the participation and (or) in favor of persons under sanctions.

- 4. The prohibitions provided for by this resolution are implemented if the persons implementing special economic measures have information that the action is being performed in favor of the persons under sanctions.
- 5. Determine the Ministry of Finance of the Russian Federation as the responsible body for sending proposals to the Government of the Russian Federation:

for changes to the list. approved by this resolution;

on granting temporary permits to conduct certain transactions with persons under sanctions.

6. This resolution comes into force from the date of its official publication.
